#### <u>RECOMMENDATION</u>

It is recommended that the Board of Directors of the San Joaquin Area Flood Control Agency adopt a resolution authorizing the Executive Director to seek Statements of Qualifications and Proposals to select an engineering firm to provide construction management and inspection services for the Smith Canal Gate project.

#### DISCUSSION

#### **Background**

In November 2013, the Board authorized a consultant contract with Peterson Brustad, Inc. (PBI) for the design of the Smith Canal Gate project, and Task Order No.1 for the development of the project's Environmental Impact Report (EIR) and public outreach. All work performed under this contract was authorized by task orders approved by the Board.

In November 2015, the Board authorized Task Order No. 5 to initiate the design, permitting, and right of way acquisition for the project. The project is currently at the 60% design level.

As we are moving forward with the completion of design documents, professional construction management services are required. These services will provide independent and detailed reviews of draft/final construction plans and specifications to ensure that work requirements are clear and documents are coordinated. In addition, they will assist in bidding, construction, and project administration to reduce impacts to the project. Professional construction management services are also required to ensure the project is constructed according to contract requirements and in accordance with local, State and federal standards.

The activities to be performed by the selected firm will be divided into two phases. The first phase will assist the design team with a constructability review and will provide other support needed to assure the project is ready for construction. The second phase will perform the actual construction management and inspection services needed for the project.

#### **Present Situation**

It is recommended the Board adopt a resolution authorizing the Executive Director to seek Statements of Qualifications and Proposals from engineering firms to provide construction management and inspection services for the Smith Canal Gate project. Construction management activities will generally include, but are not limited to, the following tasks:

- Detailed review of draft and final plans and specifications
- Biddability and constructability reviews
- Oversight of environmental mitigation activities
- Inspection services
- Material testing
- Surveys
- Quality assurance
- Accurate record keeping of as-built drawings and preparation of red-line as-built drawings throughout the project

A selection panel will be convened by the Agency to evaluate the proposing firms' experience with similar projects, overall qualifications, key personnel, and project scope of work. Selected firms will be invited to an interview. After the interviews are concluded, the selection panel will recommend a firm for Board approval. A contract with the selected firm will be brought back to the Board for consideration and approval at the meeting on May 18.

Design is expected to be completed by the end of 2017. Construction is scheduled to begin in early 2018 and completed by the end of 2019

#### **RECOMMENDATION**

It is recommended that the Board of Directors of the San Joaquin Area Flood Control Agency adopt a resolution authorizing the Executive Director to sign an Urban Flood Risk Reduction Agreement for the Smith Canal Gate project with the California Department of Water Resources.

#### DISCUSSION

#### Background

In 2012, SJAFCA was awarded a \$2,412,500 grant from the State of California Department of Water Resources (DWR) for 50% of project design.

In July 2013, voters within the affected area passed a Proposition 218 property assessment to fund the local share (approximately 50% of design and construction) of a \$36 million project.

On February 25, 2015, the SJAFCA Board authorized a submittal of an Urban Flood Risk Reduction (UFRR) concept proposal application to seek State funding for project construction.

On March 9, 2015, SJAFCA submitted a UFRR concept proposal seeking 67% of project construction costs. Based on the evaluation of the concept proposal, DWR conditionally committed up to \$22,309,666 to complete construction of the project pending the receipt and subsequent approval of a full application (Attachment 1).

A full application requesting 67% of construction costs was submitted in August 2015. The application has been reviewed and it is conditionally approved pending the inclusion of the project in the State Plan of Flood Control (SPFC). This can be accomplished by including the project in a U.S. Army Corps of Engineers Chief's Report, and obtaining subsequent Congressional Authorization. In addition, the State is willing to include funding to complete the design activities, but funding will not be committed for construction activities until a conditional Congressional Authorization has been granted (Attachment 2).

The Lower San Joaquin River Feasibility Study which includes the Smith Canal Gate project is scheduled for completion in December 2017. Once completed a Chief's Report will be delivered to Congress for authorization to be included in a future Water Resources Development Act bill.

#### **Present Situation**

The State is in the process of finalizing the UFRR agreement. As part of the UFRR agreement the State is willing to include funding to complete the design activities. This agreement is needed as the allocated funding in the design agreement has been spent. However, funding will not be committed for construction activities until conditional Congressional Authorization has been granted.

Execution of the agreement will allow the State to release additional funds to complete design activities needed for the project, as well as funding for construction. Project Design is expected to be completed by the end of 2017. Construction is scheduled to begin in early 2018, and completed by the end of 2019.

Therefore, it is recommended that the Board authorize the Executive Director to sign an Urban Flood Risk Reduction Agreement for the Smith Canal Gate project with the California Department of Water Resources.

#### **FINANCIAL SUMMARY**

The State will cover up to \$22,309,666 of the project expenses, and the remaining will be covered by the Smith Canal Assessment District.

Thank you for submitting a Concept Proposal requesting funds from the Urban Flood Risk Reduction (UFRR) Program in the amount of \$22,309,666 to complete construction of the Smith Canal Gate Structure. Based on evaluation of your submittal, the Department of Water Resources (DWR) is conditionally committing up to \$22,309,666 to complete construction of the Smith Canal Gate Structure pending the receipt and subsequent approval of the full project application as described in the Guidelines and proposal solicitation package.

DWR is requesting that San Joaquin Area Flood Control Agency (SJAFCA) submit the full project application prior to June 30, 2015. The application must contain all of the required documents (Attachment 1), meet all of the requirements of the UFRR Guidelines, and be consistent with the approved Concept Proposal. We recommend providing additional information regarding the recreational component of the proposal to justify the requested cost share. Additionally, written approval by the State and appropriate Levee Maintaining Agencies is required on a Draft Amendment to the O&M Manual prior to receiving any disbursement of construction funds under UFRR.

We understand you recently filed for Section 221 with the U.S. Army Corps of Engineers. It is important that you continue to pursue approval of this Section 221. It is also critical that you work with DWR throughout the design and construction of the project to ensure compliance with all requirements (i.e., real estate, ULDC compliance, etc.) and improve upon the multi-benefit aspect of the project.

This Project may be a "covered action" pursuant to Section 21065 of the California Public Resources Code. As a result, SJAFCA will be expected to work with DWR and the Delta Stewardship Council to determine whether the project is a covered action and if so, to prepare a certification to the Delta Stewardship Council that the project is consistent with the Delta Plan.

#### SJAFCA Smith Canal Gate Construction Project Funding Update

Dear Mr. Churchwell:

This letter serves as a follow up to our conditional commitment letter sent to San Joaquin Area Flood Control Agency (SJAFCA) on May 15, 2015 (See Attached). As mentioned in previous meetings, the Smith Canal Gate Construction Project (Project) needs to be added to the State Plan of Flood Control (SPFC). This is because the funding source for the proposed Project is Proposition 1E General Obligation Bond (Public Resources Code Section 5096.821) which requires the project or project elements to be SPFC Facilities. The bond funding also has time limitations for spending the allocated project funds, which need to be considered when evaluating the progress of the project toward major milestones.

Through review of SJAFCA's concept proposal and subsequent application, DWR understands that the Project is increasing levels of flood protection as required by the Urban Flood Risk Reduction Program Guidelines for Reclamation District's 1614 and 828 areas, including the community of Stockton. DWR has identified paths for this project to be added to the SPFC and design activities to continue prior to adoption into the SPFC. The SPFC includes flood control projects for which the Central Valley Flood Protection Board (CVFPB) or DWR has provided assurances of nonfederal cooperation to the US Army Corps of Engineers (USACE). The two interrelated key steps we identified include:

- Compliance with USACE Section 408 Permission to alter a USACE Project. As with all modifications to existing Federal flood control features, the project would need to be approved under the 408 process, and/or
- Inclusion of the project in a Chief's Report and subsequent authorization by Congress.

DWR would be willing to amend the design agreement for additional funding to complete the design activities, but funding will not be committed for the real estate acquisition or construction activities until Congressional Authorization has been granted.

As long as a clear path is identified for SJAFCA to secure Federal authorization, the Project will be conditionally funded for design and CEQA/NEPA activities. If at any time Federal Authorization is not reasonably foreseeable, all funding commitments will be withdrawn and the agreement will terminate.

Given the time limitations of the Bond funding and the required duration for right of way acquisition, permitting, and construction activities as stated in the Project application package, adequate progress on securing a path to the SPFC will need to be established by December 2018. The specific definition of adequate progress will be determined by DWR and outlined in the Funding Agreement.

Please work with your Flood Projects Office project manager, Eric Martinez, to move forward on the development of a scope as explained above, and work toward executing a funding agreement for the project.
