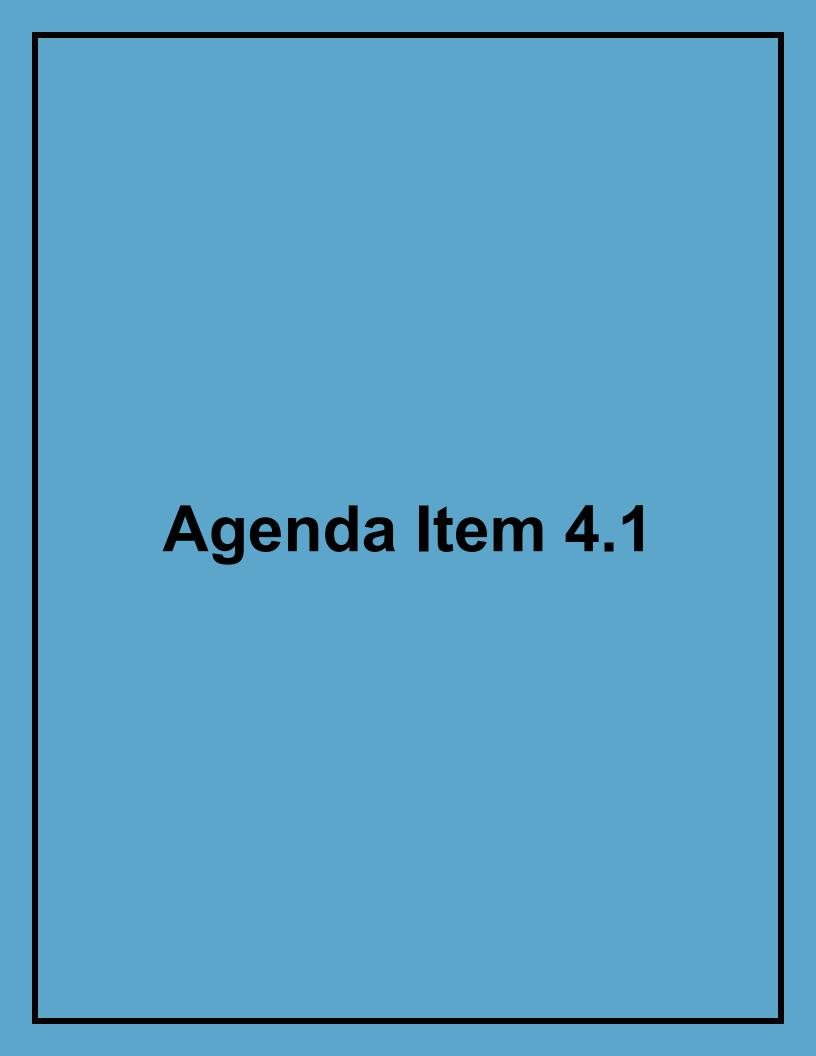

RECOMMENDATION

Conduct a public hearing on the Proposed Enhanced Infrastructure Financing District Plan

DISCUSSION

At the Mossdale Tract Enhanced Infrastructure Financing District Public Financing Authority ("PFA") Board meeting on March 17, 2022, Agency Staff and Consultants presented the Draft Enhanced Infrastructure Financing District Plan (IFP) (Attachment 1) to the Board and provided an overview of the forthcoming schedule based on Enhanced Infrastructure Financing District (EIFD) law and the prescribed process to form an EIFD. This process includes three public hearings as well as communication with landowners, residents, and taxing entities. The first public hearing took place on April 22, 2022 at which time staff provided a presentation regarding the draft IFP and the board and the public were provided the opportunity to provide written and oral comments and ask questions. EIFD law requires that at the second public hearing the PFA shall consider any additional written and oral comments and take action to modify or reject the enhanced infrastructure financing plan. It should be noted that to date no written comments have been received by PFA and SJAFCA staff and consultants.

In accordance with EIFD law, staff provided a mailed notice regarding the EIFD plan and its availability to each landowner, resident and affected taxing entity 40 days prior to the first public hearing. In addition, at least ten days prior to this hearing, staff has published a notice of this second hearing in The Stockton Record, posted a notice of this hearing on the EIFD PFA website and mailed a notice to each landowner, resident, and taxing entity.

It is recommended to hold the third public hearing on July 21, 2022 at 10:00 a.m. At the third public hearing the PFA will consider any additional written and oral comments on the IFP and will act to modify or reject the plan. Staff will ensure all noticing requirements are met for the third public hearing which includes publishing in the newspaper and posting on the EIFD website.

Staff requests that the PFA Board conduct the hearing and upon conclusion of the hearing, consider adoption of the resolution presented under Item 6.1 of this agenda.

If the IFP is not rejected at this second public hearing, then the PFA will conduct a protest proceeding at a third public hearing scheduled for July 21, 2022. Assuming no majority protest exists, at the third public hearing, the PFA would adopt a resolution adopting the plan and forming the EIFD. Between the second and third public hearings meeting will be held with the governing boards of the participating taxing entities in which the IFP will be presented to the respective governing boards for approval.

A RESOLUTION MEMORIALIZING THE SECOND PUBLIC HEARING OF THE AUTHORITY, SETTING FORTH THE SCHEDULE FOR THE THIRD PUBLIC HEARING OF THE AUTHORITY, AND OTHER RELATED ACTIONS

WHEREAS, pursuant to Resolution No. R-22-5019 adopted on January 13, 2022 (the "Resolution of Intention"), the City Council of the City of Lathrop authorized the initiation of proceedings to establish the Mossdale Tract Enhanced Infrastructure Financing District (the "EIFD") and established the Mossdale Tract Enhanced Infrastructure Financing District Public Financing Authority (the "Authority") in accordance with the requirements of Chapter 2.99 of Part 1 of Division 2 of Title 5 of the California Government Code (commencing with Section 53398.50) (the "EIFD Law");

WHEREAS, as part of the EIFD formation process, the Governing Board of the Authority ("Board") directed the preparation of an infrastructure financing plan (the "Plan");

WHEREAS, pursuant to Government Code section 53398.66(a), the Authority is required to hold a second public hearing to provide the opportunity for additional written and oral comments and take action to modify or reject the Plan;

WHEREAS, a notice of the second public hearing was duly given as required by the EIFD Law, as evidenced by the certification(s) on file with the Secretary of the Authority;

WHEREAS, pursuant to the EIFD Law, a public hearing was convened by the Board on May 26, 2022, at the hour of 10:00 a.m., or as soon thereafter as the matter could be heard, at the Stockton City Hall, 425 N. El Dorado Street, 2nd Floor Council Chambers, Stockton, California; and

WHEREAS, at the hearing, the testimony of all interested persons, including all landowners and residents within the EIFD, desiring to be heard on the draft Plan or any other related matters was heard and considered, the opportunity for additional written and oral comments was provided, the Plan was not rejected, and a full and fair hearing was held thereon;

WHEREAS, as of the date of the hearing there have been no amendments made to the draft Plan;

- **NOW, THEREFORE, BE IT RESOLVED** by the Governing Board of the Mossdale Tract Enhanced Infrastructure Financing District Public Financing Authority that:
- **Section 1.** Recitals The Board finds and determines that the foregoing recitals are true and correct.
- **Section 2.** <u>Infrastructure Financing Plan</u> Pursuant to Government Code section 53398.66, the draft Plan was presented to all interested persons, including all landowners and residents within the EIFD, at the second public hearing of the Authority held on May 26, 2022, at which time an opportunity for questions and consideration of comments was provided.
- Section 3. Third Public Hearing In accordance with the EIFD Law, the Board hereby calls the third public hearing to be held on July 21, 2022, at the hour of 10:00 a.m., or as soon thereafter as the matter could be heard, at the Stockton City Hall, 425 N. El Dorado Street, 2nd Floor Council Chambers, California, as the time and place when and where the Authority will conduct the third public hearing on the proposed Plan. Notice of Third Public Hearing. Notice of the third public hearing shall be provided in accordance with the EIFD Law. The Authority has arranged the publication of the notice of the third public hearing to be in a newspaper of general circulation in the County of San Joaquin in accordance with Government Code section 53398.66.
- **Section 5.** <u>Effective Date</u>. This Resolution shall take effect from and after its adoption.
- **Section 6.** <u>Severability</u>. If any section, subsection, phrase, or clause of this Resolution is for any reason found to be invalid, such section, subsection, phrase, or clause shall be severed from, and shall not affect the validity of, all remaining portions of this Resolution that can be given effect without the severed portion.
- **Section 7.** General Authorization. The Executive Director, the Secretary of the Authority, and all other officers and agents of the Authority are hereby authorized and directed to take all actions necessary or advisable to give effect to the transactions contemplated by this Resolution. Any actions heretofore taken by said officers and agents, on behalf of the Authority, that is in conformity with the purposes and intent of this Resolution and with the provisions of the EIFD Law with respect to the proposed EIFD, are hereby approved and confirmed.
