Some Key Findings from the GBA Presentation and Interregional Coordination Meetings:

GBA Presentation

- The GBA is preparing an IRWMP and is currently working toward prioritizing projects
- The IRWMP team was encouraged to review the draft list of RFMP projects
- The RFMP team will review IRWMP projects and include applicable flood projects in our draft list for stakeholder review/consideration

Interregional Coordination Meeting

- Held with Upper SJ, Mid JS, Lower SJ/Delta South Regions
- All three Regions are in about the same point in RFMP development (i.e. completing Flood Hazards Section, starting Project Section)
- All Regions are interested in identifying common projects and including in each RFMP (i.e. upstream storage, reservoir re-op, etc.)

Some Key Findings/Outcomes from the RFMP thus far:

- Land use agencies have become engaged in SB5 legislative relief efforts and are considering using baseline info in the RFMP to move forward with their own local plans in the near future
- Long-term flood protection goals have been identified for many areas within the Regions
- Approximately 40 projects identified from Small Group Meetings & previous/on-going studies
- Many local-level hazards have been identified; the RFMP may serve to guide local improvements after the effort is complete

Key Information Pending from DWR

- Information on key species (such as life cycles and habitat areas) and existing stressors on these species
- CVFED Task Order 25 Models (Anticipated by end of 2013)
- ULE Documentation
